

Liquor Portal Registration

To register and set up your Liquor Portal account, you will need your liquor licence number and PIN. This information can be found on your last renewal notice or by emailing <u>contact@vcglr.vic.gov.au</u>.

Note: The PIN can only be provided to the licensee. If the licensee is a company this means an approved director. If the licensee is a club this means a senior committee member.

- 1. Type in <u>liquor.vcglr.vic.gov.au/liquorportal/</u> to your web browser.
- 2. Select **Register an Account** on the home page.

Welcome to the Liquor Portal The Liquor Portal is designed to help licensees manage their existing liquor licence, lodge a new restaurant and cafe licence application or transfer an existing licence. 7. Once you have completed the images verification, tick the I'm not a robot box and register box.



8. You will now see the screen below. Open the email account you provided in Step 3 as a validation email has been sent to you.
